## MEETING MINUTES

March 17, 2015

A Meeting of the New Britain Township Parks and Recreation Advisory Board was held on January 20, 2015 at the Township Administration Building, 207 Park Avenue, New Britain Township, Pa., beginning at 7:00 p.m. In attendance were: Marco Tustanowsky, Charles Maeyer, William Jones, Dan Mackintosh, James Bender, Nancy Jones, Regina Armitage, Samuel Garcia and David Turcich. Also, in attendance was Jo Ann Lapp, New Britain Township Staff.

**1. Approval of Minutes of January 20, 2015:** Upon motion by Mr. Maeyer, seconded by Mr. Bender, the January 20, 2015 minutes were unanimously approved as written.

**2. Easter Egg Hunt:** Wayne Fultz, Public Works Superintendent, will make a decision on Thursday regarding the use of the fields for the egg hunt.

**3. Ribbon Cutting Ceremony – West Branch Park:** The ceremony will be on April 18<sup>th</sup> with a rain date of April 25<sup>th</sup>. Mr. Tustanowsky told the Board that Ms. Bradley, Township Manager, has a list of speakers that she would like invited. Ms. Lapp will talk with Ms. Bradley to finalize the list of everyone to be invited to speak.

The ceremony will be advertised, invitations will be sent and the Intelligencer will be invited. Ms. Lapp has a meeting with the Lenape Valley coaches on Thursday; she will speak with them about a starting time.

**3. Green Fest:** Ms. Lapp asked Mr. Tustanowsky if the Board could set something up at the Fall Festival. He said that they are always looking to add vendors to the Festival. Ms. Lapp will create an outline for the next meeting.

### 4. Other Business:

Mr. Jones asked if there is interest in having Movie Night again this year. Everyone agreed they would if sponsorship can be found. Mr. Bender will speak with North Wales Water to see if they would sponsor again this year. Mr. Tustanowsky informed the Board that the Veteran's Committee will also be having a Movie Night this summer. Mr. Bender will call the movie guy and ask him what nights he has available.


