Pre-Budget Activity

- Staff began work on the Budget with the instructions from the Board of Supervisors to balance the budget
- The Board asked staff to prepare a Budget reflecting a one (1) mill increase in Real Estate Tax for the Park & Recreation Fund and 0.100% increase in Open Space Earned Income Tax (OSEIT) to fund Cotton Park, the Neshaminy Greenway Trail, and other park and trail connections within the Township.
- Prior to preparation of the Budget, Staff continuously reviewed financial status
- Careful and considered spending policies continue to be used for all purchasing throughout the year, regardless of Budget Season
- Annual review of all ongoing routine expenses, contracts, utility charges, etc., ensures cost savings for the best materials and services





Key Revenue Sources

- Real Estate Tax
 - Increases due to recent development.
- Earned Income, LST Taxes
 - EIT collections continue to increase gradually, based on normal inflation, new residents.
- Permit Fees
 - Due to recent development.

Cost Containment

- The Township joined a cooperative bidding program to replace Streetlights throughout the Township with high efficiency LED heads.
- The Savings in maintenance costs and utility charges is guaranteed to cover the cost of the debt service to purchase the streetlights from PECO, and install the new heads within seven years.



Cost Containment

 Both Township-owned and District Street Lights have been upgraded to highefficiency LED heads.

 District Streetlight rates were reduced for 2019 to reflect cost savings in utility and maintenance charges, and remain at the reduced 2019 rates.



Expenditures



- One new Police vehicle
- New Fuel Dispensing Systems for PD and PW
- Computer upgrades through all Departments
- \$5,000 toward a Pilot Program to expand the Doylestown DART bus along Business Route
 202 up to County Line Road

- \$220,000 new Traffic Signal System at New Britain Boulevard and County Line Road
- One 1-Ton Pick Up Truck with Plow, Salt Spreader and Liftgate

- The Township borrowed \$3,000,000 in 2018 for reconstruction of the New Galena Bridge (completed in 2019)
- Four culverts throughout the Township were replaced in 2019, with one still outstanding, under the same funding
- Building improvements and Capital Purchases may also occur in 2020, with any remaining funds from the loan



Park and Recreation

- New Britain Township continues to improve its Park System through capital improvements and working with developers to enhance facilities
- Presently, New Britain Township owns and maintains over 265 acres of active and passive recreational parkland
- The Township is working on bringing forward premier facilities at Cotton Park on Schoolhouse Road

- Phase One development of Veterans Park is completed, with additional purchases in 2020 (monument, benches, picnic tables, landscaping)
- Neshaminy Greenway Trail development and construction will proceed from 2020 through 2021

- Cotton Park design will continue through 2020, along with application to DCNR for grant funding
- North Branch Park will receive a new Play Structure, benches, and refurbished backstops on all fields

- Maintenance and upkeep of the entire Park System is also budgeted
- Installation of a Dog Park is in the planning phase



Debt Service

- Public Works Building debt service of \$224,500. Loan matures in 2025
- \$3,000,000 Bridge Project debt service of \$161,000. Township will continue to draw down on the loan through early 2020. Loan matures in 2031
- Regional Streetlight Procurement Program debt service of \$26,000 over 7 years, maturing in 2024



Debt Service

• Total Debt Service for FY 2020 is \$411,200

 The Township may consider consolidation or refinancing of all debt at the time of maturity of the PW Building debt in 2025



Interfund Transfers

- \$100,000 will be transferred from Land Preservation Fund to Park and Recreation Fund for maintenance and development of parks and open space
- \$21,287 will be transferred from Street Light Fund to Street Light debt service for the District portion of the debt service on the LED upgrade



Interfund Transfers

- \$220,000 will be transferred from Fiduciary Fund to Capital Infrastructure for a new Traffic Signal System at New Britain Boulevard and County Line Road
- \$100,000 will be transferred from General Fund to General Reserve



Land Preservation

- To date, New Britain Township has preserved over 900 acres
- Total conserved acreage throughout the Township (publicly, privately, through development, etc.) is 2,400+ acres
- The Township has over \$1,675,000 for Open Space acquisition in a dedicated fund



Land Preservation

- There are approximately 300 acres listed in our Open Space Plan (2008 Supplement) as "Priority Land Preservation Sites" that the Township continues to actively pursue
- The Township also looks for opportunities to piece together important parcels in significant areas that may not be listed in our Open Space Plan



Land Preservation

- Dedicated real estate millage for land preservation was discontinued in 2011 and is not part of this 2020 Budget
- Through a voter referendum in 2000, the Township instituted a 0.125% Earned Income Tax dedicated to Open Space Acquisition. For 2020, a tax rate of 0.125% OS EIT will garner approximately \$595,000

2020 Proposed EIT Tax

- Tax of 1.00% of Earned Income for General Purposes (0.5% to Township; 0.5% to CBSD).
- Tax of 0.125% dedicated for Open Space Land Acquisition for Fiscal Year 2020
- There is a 0.100% increase from 2019 EIT taxes, for as total of 1.125%
