MEETING MINUTES MARCH 21, 2023

A Meeting of the New Britain Township Park and Recreation Board was held on March 21, 2023, at the Township Administration Building, 207 Park Avenue, New Britain Township, Pa., and with the use of the Zoom Video Conferencing Platform, beginning at 7:01 p.m. In attendance were Nancy Jones, Jessica Young, Renee Steskal, Kathi Dutill, Brooke Newborn, and Cynthia Jones. Also, in attendance were: Bill May, and Christine Nicholas New Britain Township Staff.

- **1. Approval of Minutes from February 21,2023:** Upon motion by Nancy Jones seconded by Renee Steskal the February 21, 2023, minutes were approved as written.
- 2. Easter Event: Event Coordinator Christine Nicholas notified the Advisory Board that all the necessary items and supplies were purchased and ready for the event, including a new easter bunny costume. Volunteer assignments were acknowledged and adjusted accordingly. Bill May will make the adjustments to eliminate the need for parking personnel, as well as set up for the event, Flyers have been sent out, and the event has been posted to Township website.
