## **PARADE RULES & REGULATIONS**

To ensure the safety and enjoyment of the public and spectators, participation in the Tri-Municipal Parade is limited to individuals or groups that have been **pre-approved**. All participants are required to follow the rules and regulations below. Failure to comply may result in immediate removal from the parade and, depending on the severity of the violation and level of cooperation, possible police action.

### **1. Political Signs and Activities**

The parade is intended for the enjoyment of spectators and to honor the anniversary of our country's independence. It is **not** a forum for political campaigning.

- No solicitation of votes is permitted.
- No distribution of political literature of any kind is allowed.
- No signs asking spectators to "vote for" any candidate.
- Political organizations may participate with floats and/or signs **for identification purposes only**.

## 2. Loud Noise and Sirens

Each year, we receive complaints about loud air horns and sirens frightening babies, small children, parade animals, and individuals with sensitive hearing.

- All participants must be mindful of this issue.
- Any use of air horns or sirens must be limited to **short bursts** and used at the **lowest volume possible**.

## 3. Careless Driving

To protect spectators and participants:

- Spinning tires or any form of careless or unsafe driving is strictly prohibited.
- All drivers of motorized vehicles must be **at least 16 years of age**.

## 4. Maintaining Pace

- All parade marchers and vehicles must maintain a steady, continuous pace.
- Please do **not** stop along the route to perform demonstrations or routines.
- Demonstrations may be performed **after the parade** at North Branch Park (on the soccer fields across from the Pavilion).

## 5. Distribution of Candy, Toys, or Other Items

- Do **not** throw candy, toys, or any items from vehicles. This creates a serious safety hazard, especially for children who may run toward moving vehicles.
- If you wish to distribute candy or trinkets, please have someone walk **alongside** the vehicle and **hand items directly** to spectators.

### Notice from the Police Department

Please be reminded that many vehicles in the parade (such as dirt bikes, ATVs, tractors, etc.) are **not permitted on public roads under normal circumstances**.

Once the parade concludes, these vehicles **must not continue to operate on public roads**.
